END USER LICENSE AGREEMENT

IMPORTANT—PLEASE READ CAREFULLY. YOUR USE OF THE **TILLS Easy-Score™** WEB SITE, **www.tillseasyscore.com** ("SITE"), AND **TILLS Easy-Score** SERVICES AND ASSOCIATED SOFTWARE ("SERVICES") IS CONDITIONED UPON YOUR ACCEPTANCE OF AND COMPLIANCE WITH THE TERMS OF THIS END USER LICENSE AGREEMENT AND ITS RELATED TERMS OF USE AND PRIVACY POLICY.

TILLS Easy-Score is a web-based scoring system for the *Test of Integrated Language and Literacy Skills™* (*TILLS™*). This TILLS Easy-Score™ End User License Agreement ("Agreement") is a legal agreement between You and Paul H. Brookes Publishing Co., Inc. ("Brookes Publishing Co."), a Maryland corporation using the mailing address P.O. Box 10624, Baltimore, Maryland 21285. "You" refers to any individual or entity who has or gains access to use the Site and Services. (An entity, by way of example but not exclusively, could be a school, private clinical practice, school district, educational system, hospital clinic, or therapeutic or health care practice.) TILLS Easy-Score™ is an interactive, evolving system, and enhancements to the existing functionality as well as new features may be added at any time. This Agreement covers the current and all future iterations of the system. TILLS™ and TILLS Easy-Score™ are protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. TILLS Easy-Score™ is licensed on a complimentary basis to You as a legitimate user of TILLS™ at Brookes Publishing Co.'s sole discretion. No ownership rights are conveyed with this nonexclusive, nontransferable, revocable license. For purposes of this Agreement:

- (a) "Site" means the portions of TILLS Easy-Score™ that can be accessed only by use of a username and password.
- (b) "Services" means all features of the Site including but not limited to those services that assist in scoring the assessment results for students.
- (c) "Content" means the text, pictures, sound, graphics, logos, marks, symbols, software, and tools used in conjunction with, or otherwise made available through, the Site by Brookes Publishing Co.
- (d) "Student Data" means any user-supplied and user-generated data associated with a single student including but not limited to student information, test information, TILLS raw scores, and automatically generated scores, including those results in the automatically generated PDF.
- (e) "Account" means the specific relationship with Brookes Publishing Co. established to provide for Your access to the Site and Services.
- **1. Grant of License.** The Site and the Content contained hereon are the sole and exclusive property of Brookes Publishing Co. and are protected by United States and international copyright laws.
